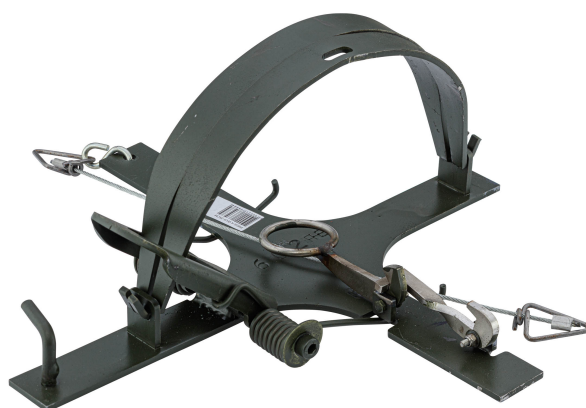

Counterfoil egg trap, approved by the Ministry of the Environment.

The **Europ-Arm** professional egg trap is designed for the regulated trapping of mustelids, with precise triggering upon contact with the bait.

Robust and durable, it meets the requirements of licensed trappers and current French regulations.

- **Diameter:** 25 cm
- **Material:** Laser-cut steel
- **Protection:** Anti-corrosion cataphoresis painting
- **Approval:** Ministry of the Environment PHE 610
- **Category:** II (regulated trapping)

A regulatory trap designed for the field

Designed for regulated population control operations, this egg trap is intended for trapping **beech martens** and **pine martens** in strict compliance with French legislation. Its operation is based on a simple yet remarkably effective principle: it is triggered only when the animal comes into direct contact with the bait.

Direct contact triggering mechanism

In practice, the egg, when placed flat, acts as a trigger. As soon as it is handled by the mustelid, the mechanism is instantly armed. This design allows for **selective capture**, limiting the risks to non-target species when used under the intended conditions.

Robust construction and corrosion protection

Made from laser-cut steel, the trap benefits from a cataphoresis finish. This treatment ensures excellent resistance to humidity and oxidation, a valuable feature for use in agricultural settings, outbuildings, or old buildings.

Recommended installation conditions

Positioning is crucial. The trap is usually set in a fake nest, with only the egg remaining visible. Indoors, attics, barns, or chicken coops are ideal locations. Outdoors, use is limited to nighttime or requires a secure box.

- **Use:** primarily indoors, outdoor use under certain conditions
- **Control:** mandatory daily check
- **Safety:** Keep children and pets away

Professional instructions

Installation and use procedure reserved for **approved trappers** , intended to ensure effective and selective capture of mustelids, in compliance with regulations.

Pre-bait the area

Place an egg several days before installation to accustom weasels or martens to frequenting the chosen location.

Position the bait

Place a fresh egg flat in the center of the trap, without securing it, to ensure it is triggered on contact.

Conceal the trap

Install the whole thing in a fake nest or a natural setting, making sure that only the egg remains visible.

Arm the mechanism

Arm the triggering system only when the trap is being put into service.

Check daily

Check the trap every day, in accordance with the legal obligations applicable to regulated trapping.

FAQ

Is this trap available for sale?

No, this is a category II trap reserved exclusively for licensed trappers, in accordance with current regulations.

In what places can it be used?

It is primarily intended for indoor use (attics, barns, chicken coops). Outdoor use is strictly regulated.

What kind of maintenance should be planned?

Regular cleaning and checking of the mechanism are sufficient. The anti-corrosion treatment reduces long-term maintenance.
