Design and realism

The **MK18 RIS II** Double Eagle is constructed **entirely of metal** with **official Daniel Defense engravings** . Its **anodized bronze** handguard features top, side, and bottom **RIS** rails, allowing for customization with tactical accessories (grips, lights, optics). The **non-slip pistol grip** and the EMG-branded **Daniel Defense stock** ensure a secure hold and optimal shooting comfort.

High-performance internals and compatibility

Based on **Tokyo Marui's MWS-type** mechanics, this replica ensures compatibility with **MWS magazines and parts** . Its **reinforced trigger box** and **high-performance nozzle** guarantee a smooth cycle, excellent air seal, and exemplary firing consistency. The **14mm CCW** thread accommodates a metal flash hider and allows for the mounting of a suppressor or tracer.

Versatility and maintenance

Ideal for players seeking a realistic and durable GBBR replica, the MK18 RIS II impresses with its two-tone black/bronze look and high-quality finish. Maintenance is simple: regular cleaning of the **barrel** and **hop-up** , along with **silicone lubrication**, ensures longevity and performance. Its powerful blowback and reliability make it an excellent choice for intensive use.

How powerful is this replica and is it legal?

This replica has a power output of less than two joules and will allow play on the majority of fields in Europe.

What type of gas should be used for proper operation?

This replica uses **GBBR gas** such as Nuprol 4.0. Using a less powerful gas suitable for the temperature in summer, such as Nuprol 2.0 or 3.0, will help maintain stable velocity and preserve the seals.

What maintenance is recommended for this model?

Maintain the replica regularly: clean the barrel, lightly lubricate moving parts, and check the seals. Use only silicone-based products to prevent premature wear.

Remember not to leave the replica in the sun during periods of high heat.

Are the chargers compatible with other models?

Yes, the replica is compatible with **Tokyo Marui MWS magazines** as well as with the majority of MWS standard GBBR magazines available on the market.

Can accessories be mounted on this replica?

Yes, thanks to its **RIS** handguard and **14 mm CCW thread** , you can attach a wide range of accessories: optics, grips, lights or silencers depending on your needs.
